The above named LESSEE hereby contracts with the LESSOR (ESDCTA) to lease the equipment detailed below at the Horse Park of New Jersey for the event and dates above.

The LESSEE agrees to full responsibility for: removal of the equipment from storage, use at the Horse Park, cleaning, and returning equipment to, or into, the storage area. The LESSEE will report any equipment damage to the ESDCTA Equipment Manager within 3 days. An estimate for repair, or replacement of the damaged equipment, must be submitted to the ESDCTA Equipment Manager within 7 days. The security deposit will be used for repairs or replacement of the equipment. If the security deposit does not cover the full cost of such repair or replacement, the LESSEE will submit an additional check within 14 days to cover the remaining balance. If the repair/replacement is less than the security deposit, the balance will be returned to the LESSEE within 14 days.

### LIABILITY and INDEMNITY

Liability for injury, disability or death of persons caused by the handling, use or transportation of the equipment during the term of the lease, is the obligation of the LESSEE and the LESSEE shall indemnify and hold the LESSOR harmless from and against all such liability.

### INSURANCE REQUIREMENTS

LESSEE must provide LESSOR with a Certificate of Liability Insurance naming ESDCTA, the LESSOR, as the Certificate Holder and Additionally Insured with respect to the Insured's use of the equipment detailed below.
